Minutes of Annual General Meeting held at The Town Close Auditorium, the Castle Museum, Norwich on 9th September 2017 at 1.30pm

25 Members attended

The Meeting opened with a welcome from the President, Sophie Cabot, who introduced the new trustees in attendance. AIMS and OBJECTIVES

The Norfolk and Norwich Archaeological Society (the Society), formed in 1846, exists to advance the education of the public through the study of archaeology in Norfolk, which includes as ancillary to this:

1. The study of the history, architecture and antiquities of Norfolk;
2. The collection and publication of information on the ancient arts and monuments of the county;
3. The encouragement of individuals and public bodies in making researches and excavations;
4. The prevention of injury to and destruction of all kinds of objects of archaeological value.

ADMINISTRATION and CONSTITUTION

The Society is governed by its own constitution and is a registered charity as defined by the Charities Acts 2006 and 2011. (Charity Number 31116)

Each trustee signed a trustee eligibility declaration and the Society has in place a trustee insurance policy through Towergate Insurance.

Trustees' responsibilities

The Trustees have and accept ultimate responsibility for directing the affairs of the Society, and ensuring that it is solvent and well-run, and for delivering the charitable outcomes for the benefit of the public for which it has been set up. They are responsible for safeguarding the assets of the Society and taking reasonable steps to prevent fraud and other irregularities. They must ensure that the Society complies with charity law, and with the requirements of the Charity Commission, in particular that the Society prepares an annual report on what it has achieved and annual returns and financial statements as required by law.

In preparing those financial statements, the Trustees are required to:

- Select suitable accounting policies and then apply them consistently
- Make judgements and estimates that are reasonable and prudent
- Prepare the financial statements on a going concern basis unless circumstances dictate that to do so would be inappropriate.
- Take special care when investing the funds of the charity, or borrowing funds for the charity

The Trustees receive support and advice from the Council which consists of the Trustees, the vice-presidents, the officers and other elected members.

Recruitment and appointment of new Trustees

The Society requires a good selection of skills amongst the Trustees to cover all the areas which the Society encompasses. The new Trustees intend putting in place recruitment, selection and induction procedures as recommended by the Charity Commission. Role descriptions are being agreed and issued. A number of policy documents are under consideration. All the trustees, other Council members and officers are volunteers; the Society has no paid staff.

Risk Assessment

The Trustees have reviewed certain risks to which the Society is exposed (financial, membership and location of the library) and have produced a risk assessment document and a health and safety policy to take such matters into account.

A major risk for the Society arises from the need in 2019 to move the library from its present shared premises in the Cathedral Close to a new site enabling satisfactory public access. Exploration so far suggests that the likely ongoing costs of suitable premises may be such as to inhibit the Society's ability to continue to make grants on the scale of recent years.

PUBLIC BENEFIT

The Trustees confirm that they have complied with the duty in section 4 of the Charities Act 2006 to have due regard to the Charity Commission's general guidance on public benefit. The purpose of the charity is encapsulated in its objects to make available its resources to as wide an audience as possible, to encourage the study of the history, architecture and antiquities of Norfolk.

To this end the library is open two mornings a week; lectures are open to the public; and the Society website gives all necessary general information to ensure that the public can benefit from its services. The range of activities listed below makes a positive contribution to the study of Norfolk archaeology and contributes significantly to achieving the aims and objectives of the Society.

The Society has undertaken the following activities during the year to achieve its objectives for the benefit of members and the public.

EXCURSIONS

Alistair Graham Kerr resigned as Hon. Excursions Secretary in December 2016. He had proposed several visits for April-July (and other suggestions were made at Joint Trustee/Council Meetings) but none of these took place. On Saturday, 29th July 2017, Dr Paul Richards arranged a King's Lynn walk through its historic riverside streets including important archaeological sites. It was not until October 2017 that Margaret Gooch took over as the new Hon. Secretary for Excursions to plan events for 2018.

Four-day visit to Inverness

The Society had never made a trip by air before but on Friday, September 29th twenty-one members boarded a plane at Norwich airport early in the morning and landed at Aberdeen 08.05, staying at a hotel in Inverness. Our ex-County Archaeologist, Brian Ayers led the excursion visiting the following places before returning to Norwich, Monday October 2nd.

Day 1: Huntly Castle, Elgin, Spynie Palace, Sueno's Stone

Day 2: Portmahomack and the Cromarty Firth

Day 3: Loch Ness including Urquhart Castle, Culloden and Fort George

Day 4: Clava Cairns and Loanhead Stone Circle

Our Treasurer, Roger Bellinger made all the transport arrangements and collected payments. He presented a Final Account for the trip to the October Joint Trustee/Council Meeting in which receipts of £11,272 exceeded costs by £251.

PUBLICATIONS

The publication of Volume XLVII Part III 2016 of Norfolk Archaeology was delayed during 2016, and appeared in early 2017, printed by Barnwells of Aylsham and distributed by a commercial mailing company. The volume was produced by the editors Dr Sarah Spooner and Dr Jon Gregory, and the design work was carried out by Dr Richard Hoggett following the format developed by the late Trevor Ashwin. Back issues of Norfolk Archaeology are being sold by the City Bookshop, Norwich, with part of the proceeds remitted to the Society. Volume XLVII Part IV 2017 (an index volume) was worked on during the year.

WEBSITE and SOCIAL MEDIA

The untimely death of webmaster Trevor Ashwin in December 2016 resulted in continuity issues. The website was down for several weeks early in 2017 due to non-payment of hosting fees and the host's own in-house problems meant that the website files were lost. It was up and running again in May, using an old format restored from an archiving site. A new website was designed and this replaced the old version from July onwards. News is updated regularly. Based on statistics supplied by the host, the majority of visitors are from the UK, but we also have a substantial number from the USA. The index page is the most viewed, followed by the activities, contacts, news and library pages, with the YAC page getting the fewest visits.

A Facebook page has been set up, with Sue Anderson and Sophie Cabot acting as administrators. At the time of writing it has over 300 followers, mostly in the UK, but perhaps only a third in East Anglia. Posting of events has resulted in a high turnout for a number of lectures this year, adverts for which have been shared widely.

A Twitter page was set up at the same time but has fewer followers, only 116 at present, probably because it is less active than Facebook. Most of the followers are local heritage groups or individuals and we hope to build on this in the future.

A YouTube account has also been set up for the group, and one of the most popular lectures of the year, on the Great Ryburgh Saxon burial site, was filmed and is available for anyone to watch. So far it has had 77 views.

NEWSLETTER

Two newsletters were issued this year, in Spring and Autumn. The newsletter was designed using a new booklet format, rather than the old broadsheet style, and seems to have been well received. Topics covered included local society fieldwork reports, lecture programmes and NNAS news

LIBRARY

The library collection at 64 The Close, Norwich continues to be catalogued maintained and updated by a volunteer, Angela Martin and the Librarian, Judy Sims. During 2017, 178 items were added to the collection, and we extended our numbering on the original system to include items unlisted originally. These may be browsed via the Society's website. The online catalogue hosted by Michael Holmes has been restored but queries can also be addressed to the Librarian via the society webpage.

WORKING PARTIES

a) Working Party on Digitising Archaeological Journals

The digitisation includes 170 parts of the Journal; 4 index volumes; 1 Centenary volume plus the Minute Books. Three quotes were considered plus a potential source of funding from the Mark Fitch Fund for 50 per cent of the cost. The trustees agreed to proceed with Townsweb Archiving and approved a budget of up to \$6500 to be committed when 50% is promised by the Marc Fitch Fund, making the Societies final contribution in the region of £3250.

b) Working Party on the Library Move

The decision of the Sainsbury Institute to cease occupation of 64 The Close means that the Library will need to find new premises 2019/2020. The original suggestion of inclusion in the Dean & Chapter Cathedral Library was explored at length with several inquiries and proposals put forward by Dr. Victor Morgan. However, the Trustees/Council concluded that this was a non-starter because of the lack of space for storage and office facilities, problems of access and usage, and the possible disposal of volumes and loss of a distinctive NNAS library identity.

The working party has made inquiries of the Norfolk Record Office for use of rolling shelves at the end of the reading room currently occupied with microfiche readers. This would provide adequate storage and open access at a reasonable cost. Negotiations continue.

YOUNG ARCHAEOLOGISTS CLUB (YAC)

The branch of this national club is organised by Sophie Cabot with help from the following volunteers: Giles Emery, Lawrence Storey, Lizzy Stewart and Gloria Gibbons. It continues to flourish and had a full program of 10 meetings in 2017, plus additional fieldwalking and test pitting session, including a very successful day with the Caistor Roman Project at the Old Hall excavation.

GRANTS

The Society continues to support local archaeological activities and publications with grants. These are applied for using the Society's grant application form, with letters of support, and then agreed to (or not) by the Trustees. Grants approved during 2017 were:

10.01.2017 *Publication of Late Bronze Age Hoards* £2000. A definitive statement on all Norfolk late Bronze Age hoards reported from the late eighteenth century up to 1950, by Andrew Lawson.

11.07.2017 *Tasburgh "Imagined Land" Project* £1.100 to support historical research and archaeological excavation by volunteers from Tasburgh, and professionals, the Norfolk Archaeological Trust and NAHRG.

FINANCIAL REVIEW

The financial statements for the year ended 31 December 2017 appear on pages 8 to 14 with the report of the Independent Examiner on page 15. At 31 December 2017 the balance at Barclays Bank on current account was £36,966 and the balance at Leeds & Holbeck Building Society was £16,960. The portfolio was valued at £429,130 and, together with Building Society interest, generated an income of £14,832 for 2017. Total Society income was £25,780 and expenditure £22,400. Net assets amounted to £473,034.

Reserves policy

The Society's reserves are not restricted and are believed to be sufficient:

(a) to provide funds to safeguard our service commitment in the event of delays in receipt of, or reduction in, membership subscriptions, or in the event of material unforeseen expenditure.

(b) to cover expenditure, without which the Society could not function, for a period of 3 years running costs. The Trustees believe that reserves should be at least this level to ensure the Society runs efficiently and meets the needs of its members and the public.

(c) to provide extra funds which can be designated to specific projects and/or deal with unforeseen emergencies.

(d) to provide for the purchase or hire of premises, sufficient to hold and operate the Society's library collection, which needs to be re-housed by 2019

Investment policy and objectives

The principle asset of the Society is its portfolio of investments which arise from the sale of a property in central Norwich, originally willed to the Society, which was sold in 2005 realising £270,000. Invested then under discretionary management, the portfolio was valued at 31 December 2017 at £429,130. The portfolio represents the Society's principal reserve, is unrestricted and is considered more than adequate to meet any unexpected call on the Society's funds while meanwhile providing a net income of approximately £10,000 per annum after management charges. It is invested in accordance with the Society's constitution and the Trustee Act 2000. In line with Sections 4, 5 and 15 of that Act, the Trustees have put in place an investment policy document with Investec Wealth & Investment Limited. The overall objectives are to create sufficient income and capital growth to enable the charity to carry out its purposes consistently year by year with due and proper consideration for future needs and the maintenance of, and if possible, enhancement of the value of the invested funds while they are retained. The objectives are to be achieved by investing prudently in a broad range of fixed interest securities, UK and overseas equities which are quoted on a recognised investment exchange, and unit trusts and OEICs (open ended investment companies) which are authorised under the Financial Services and Markets Act 2000.

The investment policy criteria are a balanced return between income and capital at medium risk and a discretionary mandate over a 10 year + time horizon. The portfolio asset allocation falls within broad planning ranges and the performance is measured against a weighted average of the movements in the comparative indices (a bespoke benchmark). There is no investment in unquoted securities. Dividends and interest are paid into the Society's bank account quarterly. A recent calculation demonstrated that the increase in value over twelve years approximated to the increase in the Retail Price Index over the same period after allowing for minor further investment.

The investment policy document agreed with Investec contains the following paragraph:

The trustees reserve the right to exclude companies that carry out activities contrary to their aims or from holding particular investments which damage the Charity's reputation. Trustees expect the fund manager to have considered the suitability of investments of the same kind as any particular investment proposed to be made or retained.

The investment policy document and its arrangements will be reviewed regularly by the Trustees.

FUTURE DEVELOPMENTS

The Trustees intend:

- To improve publicity to increase the membership and encourage participation in the Society's activities
 - To continue to enhance the content of the Society's website
 - To arrange digitisation of past copies of *Norfolk Archaeology*
 - To put in place a series of policy documents such as data protection, etc, as well as role descriptions/procedures for Officers and Hon. Secretary.
 - To investigate future location possibilities in preparation for the library move from the Cathedral Close in 2019/2020.

1. ACCOUNTING POLICIES

- (i) These accounts have been prepared in accordance with Charities SORP [Accounting and Reporting by Charities: Statement of Recommended Practice] and with applicable accounting standards
- (ii) The Society publishes Norfolk Archaeology, a refereed journal, of which one part is published annually. The costs of production and despatch of the part issued for any year is provided for in the accounts of that year together with any recoveries expected from other organisations.

2. MANAGEMENT COSTS, TRUSTEE EXPENSES AND RELATED PARTY TRANSACTIONS

As explained in the trustees' report the management and activities of the Society are directed by the trustees and officers who are in every case volunteers. In consequence there are no staff costs.

Librarian's Expenses, Note 4, and Other Costs, Note 6, include the cost of stationery, postage and sundry supplies and services and the costs of certain other outlays reimbursed to trustees and officers of the society totalling £614.

Mr Trevor Ashwin, formerly a Council member and Society officer, who died in January 2017, supplied typesetting and document design services to the Society in respect of the journal, newsletters, website and library. Total payments for these services during 2016 amounted to £1,647. In 2017 £720 was paid to his estate in respect of services provided in the previous year
