#### **AIMS and OBJECTIVES**

The Norfolk and Norwich Archaeological Society (the Society), formed in 1846, exists to advance the education of the public through the study of archaeology in Norfolk, which includes as ancillary to this:

- 1. The study of the history, architecture and antiquities of Norfolk;
- 2. The collection and publication of information on the ancient arts and monuments of the county;
- 3. The encouragement of individuals and public bodies in making researches and excavations;
- 4. The prevention of injury to and destruction of all kinds of objects of archaeological value.

#### **ADMINISTRATION and CONSTITUTION**

The Society is governed by its own constitution and is a registered charity as defined by the Charities Acts 2006 and 2011. (Charity Number 311116)

Each trustee signed a trustee eligibility declaration and the Society has in place a trustee insurance policy through Towergate Insurance.

## **Trustees Responsibilities**

The Trustees have and accept ultimate responsibility for directing the affairs of the Society, and ensuring that it is solvent and well-run, and for delivering the charitable outcomes for the benefit of the public for which it has been set up. They are responsible for safeguarding the assets of the Society and taking reasonable steps to prevent fraud and other irregularities. They must ensure that the Society complies with charity law, and with the requirements of the Charity Commission, in particular that the Society prepares an annual report on what it has achieved and annual returns and financial statements as required by law.

In preparing those financial statements, the Trustees are required to:

- Select suitable accounting policies and then apply them consistently
- Make judgements and estimates that are reasonable and prudent
- Prepare the financial statements on a going concern basis unless circumstances dictate that to do so would be inappropriate.
- Take special care when investing the funds of the charity, or borrowing funds for the charity

The Trustees receive support and advice from the Council which consists of the Trustees, the vice-presidents, the officers and other elected members.

# Recruitment and appointment of new Trustees

The Society requires a good selection of skills amongst the Trustees to cover all the areas which the Society encompasses. The new Trustees intend putting in place recruitment, selection and induction procedures as recommended by the Charity Commission. Role descriptions are being agreed and issued. A number of policy documents are under consideration. All the trustees, other Council members and officers are volunteers; the Society has no paid staff.

#### **Risk Assessment**

The Trustees have reviewed certain risks to which the Society is exposed (financial, membership) and have produced a risk assessment document and a health and safety policy to take such matters into account.

## **PUBLIC BENEFIT**

The Trustees confirm that they have complied with the duty in section 4 of the Charities Act 2006 to have due regard to the Charity Commission's general guidance on public benefit. The purpose of the charity is encapsulated in its objects to make available its resources to as wide an audience as possible, to encourage the study of the history, architecture and antiquities of Norfolk.

To this end the library is open two mornings a week; lectures are open to the public; and the Society website gives all necessary general information to ensure that the public can benefit from its services. The range of activities listed below makes a positive contribution to the study of Norfolk archaeology and contributes significantly to achieving the aims and objectives of the Society.

#### **ANNUAL GENERAL MEETING**

The AGM took place on Saturday 20<sup>th</sup> July at the Town Close Auditorium, Norwich Castle but was inquorate and had to be re-convened at the same venue 5<sup>th</sup> October 2019 at 1.30 pm. Twenty three members attended. Sophie Cabot acted as Chairman. The Annual Report and Accounts were accepted. The Trustees, Council members and Vice-Presidents were re-elected.

A new 'JOIN US' leaflet was produced by Sue Anderson and the Hon.General Secretary sent out 125 letters to members who had not provided the Society with their emails. This enabled over 60 new addresses to be added to the database. It is hoped to produce a regular ezine for the membership to keep them informed about the Society.

The Society has undertaken the following activities during the year to achieve its objectives for the benefit of members and the public.

#### **EXCURSIONS**

A number of activities were arranged by Margaret Gooch in 2019:

Apr 10 - A mini-conference organised by the Caistor Roman Project, including a guided walk around the Roman town just outside Norwich.

May 15 - An evening walk around "Viking Norwich", led by Brian Ayers.

May 22 - A special group visit to the exhibition at Norwich Castle, *Viking: Rediscover the Legend*, with a tour given by Dr Tim Pestell.

Jul 13 - A visit to the Broadland Projects led by Professor Rob Liddiard to view the Water Mills at Hulvergate Marshes plus a tour of Acle's World War II anti-invasion defences.

# NNAS four-day excursion to East Sussex, October 2019

Dr Andrew Rogerson led the group and provided information notes about the area. Roger Bellinger made the logistic and financial arrangements. A varied programme included visits to two Iron Age hill forts (Hollingbury Hill and Cissbury Ring) and the Long Man of Wilmington on Windover Hill; three castles (Eynsford, Arundel, and Lewes); two coastal sites (including the fort at Newhaven and the Roman castle walls at Pevensey); two restored monastic buildings (Michelham Priory and Bougham Abbey); four Saxon-Norman churches; and a Roman villa at Lullington. Altogether an enjoyable and rewarding trip for the participants.

Attendances remain pretty healthy, apart from the disappointing turnout in October, although bad weather may account for some of that shortfall.

#### **PUBLICATIONS**

Dr Jon Gregory and Dr Sarah Spooner resigned as Joint Editors of *Norfolk Archaeology* in July 2019 but agreed to complete the 2018 volume, with Rik Hoggett as typesetter.. Dr Clare Haynes, Dr Andrew Rogerson and Dr John A. Davies became members of a new Editorial Board which met 17 December 2019, where Sue Anderson was appointed as Editor, a partly paid position which required her to resign as a trustee. It was agreed that the content of the Journal would remain the same for the foreseeable future: a mixture of history and archaeology, NNAS subsidised and paid-for articles, book reviews plus recent archaeology & obituaries. The board would take on the 2019 volume and aid in finding reviewers for books and possibly articles. A few had already been submitted and some had been peer-reviewed. When it became clear that the 2018 volume was still experiencing delays due to proof corrections, etc, it was decided (with the agreement of the trustees) to send both volumes to the Barnwell printers at the same time in July 2020 and hopefully save on distribution costs

# WEBSITE and SOCIAL MEDIA

The Facebook page continued with over 500 followers, mostly in the UK but perhaps only a third in East Anglia.

A Twitter page had fewer followers, less than 150 at present, mostly local heritage groups or individuals. We hope to build on this in the future.

A YouTube channel was set up and has five subscribers. It features a single video of the Great Ryburgh lecture in December 2017 which has been viewed by over 100 times

# **NEWSLETTER**

Two newsletters were issued in 2019, in Spring and Autumn, and designed using the new booklet format. Topics covered included the President's Blog, local society fieldwork reports, and a 'What's On' section, plus NNAS News and summaries of lectures. Sue Anderson resigned her position as Hon. Website and Newsletter Editor at the end of 2019 to take on the position of Hon. Editor of *Norfolk Archaeology* 

### **LIBRARY**

Since the move to the Norfolk Record Office, work has continued on cataloguing and reshelving the collection, listing by bookcase and adding the NRO location to each item. During 2019 we accessed 298 items, including a complete run of *Cornish Archaeology* donated by Andrew Rogerson; an almost complete run of *Mediieval Archaeology* {1969-2015} from Lee Hooper, and a selection of other volumes from her late husband, Richard

Darrah; plus numerous items from Raymond Frostick given to the Library by his widow Claire.

All the lists we have made, preserved on memory sticks, are being used to update the website but it is slow process. The NNAS mailing address is now c/o The Norfolk Record Office, at Martineau Lane, Norwich, NR1 2DQ.

# Digitisation of the Society's Archives

Supported by a grant from the Marc Fitch Fund, The NNAS has worked with a professional document scanning company to digitise the entire contents of 44 volumes of its journal (1847-2005), *Norfolk Archaeology* – and make over 1300 articles and images accessible for scholars, researchers and the interest public, free of charge.

Hosted by the Archaeology Data Service at the University of York, and accessed through the Society's website at <a href="www.nnas.info/NABackissues.html">www.nnas.info/NABackissues.html</a>, the articles, letters, reviews and notes cover all periods of the history and archaeology of Norfolk, and include articles by world leading experts, important archaeological discoveries, and intriguing historical research.

# YOUNG ARCHAEOLOGISTS CLUB (YAC)

The Society continues to support a thriving CBA Young Archaeologists Club branch in Norwich, which provides monthly activities in the academic year to about 20 members aged 8-16. New members are recruited regularly, and a team of 6 volunteers run the branch, including a Young Leader, an 18-year-old former branch member.

#### **GRANTS**

The Society continues to support local archaeological activities and publications with grants. These are applied for using the Society's grant application form, with letters of support, and then agreed to (or not) by the Trustees. Grants included £1000 paid in January 2919 to the Caister Research Fund; £2,500 to Norfolk Archaeological Trust towards the cost of a new guidebook for St Benets Abbey; £550 towards the publication costs of Dr Chester-Kadwell's book on Burnham Norton Friary; £2000 towards the costs of publication of a monograph on a hoard of bronze from the early Roman period found at Crownthorpe and £380 in support of the Sedgeford Anglo-Saxon Bones project. In addition the trustees agreed that £5,000 should come out of the Garland Legacy to act as a memorial to her generous gift and that this should be used to pay for the EAA monograph on the parish of Fransham by Dr Andrew Rogerson.

# FINANCIAL REVIEW

#### Legacy

The NNAS received a generous bequest from the estate of Miss Valerie Mary Garland, a resident of Bury St Edmunds, totalling £209,029. This was added to the Society's Investment portfolio managed by Investec.

# **Financial statements**

The financial statements for the year ended 31 December 2019 appear on pages 9 to 15 with the report of the Independent Examiner on page 16. At 31 December 2019 the balance at Barclays Bank on current account was £42,001 and the balance at Leeds & Holbeck Building Society was £16,976. The portfolio was valued at £652,919 and, together with Building Society interest, generated an income of £18,269 for 2019. Total Society income was £237,314, including the legacy, and expenditure £36,587. Net assets amounted to £696,690.

# Reserves policy

The Society's reserves are not restricted and are believed to be sufficient:

- (a) to provide funds to safeguard our service commitment in the event of delays in receipt of, or reduction in, membership subscriptions, or in the event of material unforeseen expenditure.
- (b) to cover expenditure, without which the Society could not function, for a period of 3 years running costs. The Trustees believe that reserves should be at least this level to ensure the Society runs efficiently and meets the needs of its members and the public.
- (c) to provide extra funds which can be designated to specific projects and/or deal with unforeseen emergencies.

# Investment policy and objectives

The principle asset of the Society is its portfolio of investments which is unrestricted and is considered more than adequate to meet any unexpected call on the Society's funds while meanwhile providing a substantial net income after management charges. It is invested in accordance with the Society's constitution and the Trustee Act 2000. In line with Sections 4, 5 and 15 of that Act, the Trustees have put in place an investment policy document with Investec Wealth & Investment Limited. The overall objectives are to create sufficient income and capital growth to enable the charity to carry out its purposes consistently year by year with due and proper consideration for future needs and the maintenance of, and if possible, enhancement of the value of the invested funds while they are retained. The objectives are to be achieved by investing prudently in a broad range of fixed interest securities, UK and overseas equities which are quoted on a recognised investment exchange, and unit trusts and OEICs (open ended investment companies) which are authorised under the Financial Services and Markets Act 2000.

The investment policy criteria are a balanced return between income and capital at medium risk and a discretionary mandate over a 10 year + time horizon. The portfolio asset allocation falls within broad planning ranges and the performance is measured against a weighted average of the movements in the comparative indices (a bespoke benchmark). There is no investment in unquoted securities. Dividends and interest are paid into the Society's bank account quarterly. The investment policy document agreed with Investec contains the following paragraph:

The trustees reserve the right to exclude companies that carry out activities contrary to their aims or from holding particular investments which damage the Charity's reputation. Trustees expect the fund manager to have considered the suitability of investments of the same kind as any particular investment proposed to be made or retained.

The investment policy document and its arrangements are reviewed regularly by the Trustees.

#### STRATEGIC PLAN

The trustees have reviewed NNAS current governance and administrative arrangements. The President produced a Strategic Plana and a Co-operation Agreement between the NNAS and the Norfolk Archaeological Trust, which included working together, sharing resources, expertise, and employment of an admin. assistant. A Governance and Admin working party have been considering various proposals.

Progress has been made in several areas as noted in this Report. Policies for governance and trustee responsibility/accountability were adopted by the trustees in November 2019 and posted on the website; back issues of *Norfolk Archaeology* were placed online and

deposited digitally with the Archaeological Data Service; a new Editor and an Editorial board are in place for the production of the 2018 and 2019 volumes of the Journal.

However, in general the NNAS has failed to increase its capacity and fulfil its mission more effectively, particularly with regard to:

- a) Increasing membership numbers and the reach of our events
- b) Communicating more effectively (with members and more widely) through publications, the press, marketing materials, the website and social media.

The full financial effects of the Coronavirus pandemic are not known but in 2020 a considerable reduction in the market value of the Society's investments is apparent and, more importantly, we are advised that the income from the investments is likely to reduce, perhaps for some years to come. Inevitably this will have its effects upon the Society's ability to spend money on grants and other aspects of the Society's operations and strategic planning.

Thanks are due to all the officers of the Society for the work they have carried out during the year.

# NOTES TO THE ACCOUNTS - YEAR ENDED 31 DECEMBER 2019

## 1. ACCOUNTING POLICIES

- (i) These accounts have been prepared in accordance with Charities SORP [Accounting and Reporting by Charities: Statement of Recommended Practice] and with applicable accounting standards
- (ii) The Society publishes Norfolk Archaeology, a refereed journal, of which one part is published annually. The costs of production and despatch of the part issued for any year is provided for in the accounts of that year together with any recoveries expected from other organisations.

# 2. MANAGEMENT COSTS, TRUSTEE EXPENSES AND RELATED PARTY TRANSACTIONS

As explained in the trustees' report the management and activities of the Society are directed by the trustees and officers who are in every case volunteers. In consequence there are no staff costs.

#### 6. DIGITISATION

During 2018 the Society arranged for the digitisation of all copies Norfolk Archaeology since the formation of the Society and also for past minutes of its Council at a combined cost of £17,530. The cost was reduced by grants from The Marc Fitch Fund totalling £7,124 leaving a net cost to the Society of £10,406. During 2019 a further £880 was spent on extracting individual papers from pdf copies of Norfolk Archaeology, renaming and saving files with page numbers and checking.

## 7. GRANTS

In 2018 the trustees approved £5,000 to be paid to the Caister Research Fund in five annual instalments of £1,000. £1000 was charged in January 2019 and a further £1,000 is reserved in these accounts leaving three further grants to be charged when paid in future years. £5,000 has been provided to pay for the Fransham publication. Other grants approved and paid in 2019 were £2,500 to Norfolk Archaeological Trust towards the cost of a new guidebook for St Benets Abbey; £550 towards the publication costs of Dr Chester-Kadwell's book on Burnham Norton Friary; £2000 towards the costs of publication of a monograph on a hoard of bronze from the early Roman period found at Crownthorpe and £380 in support of the Sedgeford Anglo-Saxon Bones project.
